Membership Agreement

We hereby agree to the membership of the person whose name appears on the Membership Application (made a part of this agreement) on the page opposite this agreement in the Hidden Pines, LLC Country Club. I, the member, agree to pay the yearly contract dues stated for the membership class chosen.

Dues are to be paid within then days of the due date. If monthly payment is chosen, payment is to be paid by the 10th of each month or late fees of 5% will be added to the balance due. If full payment is not received by the 25th day of a billing cycle, the member may be suspended from the use of the facility and golf privileges until paid in full.

All dues and cart rental fees will be paid as stated on the Membership Application or as stated herein.

All food drinks, and / or merchandise charged will also be paid monthly.

Applicant agrees to pay the yearly charge for the membership. This charge may be payable in installments as had been elected by the member on the Membership Application herein. The membership period is from March 1st to February 28th for each year and may be prorated for the current year if you join after March 1st. Hidden Pines, LLC Country Club agrees that applicant's dues will not increase nor will any assessment occur at any time except at the beginning of the new golf year. If Member defaults in the payment of the amounts due herein, Member agrees to pay all costs of collection including a reasonable attorney fee.

Member agrees that this license may be revoked by Hidden Pines, LLC Country Club for a breach of the rules as instituted time to time by Hidden Pines, LLC. The member will receive no refund or a termination for a failure to follow rules.
